Regulation 15(2) of the SEBI (LODR) regulations, 2015 grants certain relaxations which states as under -

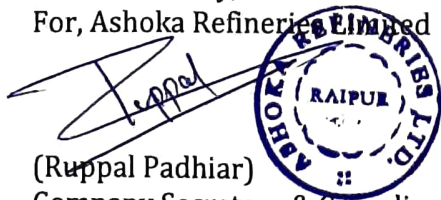
